The Pastoral Perspective

This year the arrival of Easter seems especially sweet. The winter that has passed has been harsh. Here in the Upper Valley we endured bitterly cold temperatures, while to our south, family and friends in Boston and other parts of New England endured record snowfall. From the shores of Narragansett Bay to the farthest reaches of the Northeast Kingdom, from the hills and dales of the Berkshires to the rockbound coast of Maine, the sentiment is unanimous: We are done with winter. We are ready.

Without doubt, we *are* ready for spring. But what about Easter? Are we ready for that?

Easter, of course, is not about spring. Yes, there are the shared motifs: new life, rebirth after a period of loss, a season of possibility. But the season of spring is all about the natural world, the rhythms of life. Easter is a wholly different matter. Easter is not about the natural world or, to be more accurate, the natural world alone. It is about all of Creation. Easter is not about awaking from the slumber of hibernation or shaking off of a carapace of ice and Arctic cold. Rather, Easter is about the triumph of God's love and the conquest of death.

That is quite a claim. And in the face of so much suffering in the world, whether in the cities of war-torn Syria or in the ICU at Dartmouth-Hitchcock, a seemingly empty one. If God did indeed vanquish death on the cross why is humanity—why are you, why am I—still in the grip of pain and loss?

An answer, perhaps, is to be found not on Easter but a week earlier, on Palm Sunday. When Jesus entered into Jerusalem, spectators thought they were witnessing the arrival of a new king. They were—but not the kind of king they expected. They believed a conquering heir to David had finally come to free them from Rome. What the Son of God had actually come to free them from was sin. This should not have been a surprise. That Jesus was somehow doing something new and different

BOARD OF GOVERNORS

The Board of Governors plans to schedule an **energy audit later this spring or in the fall.** The Board has met with one potential firm and is in the process of obtaining more information from a second. Ideally, the parsonage would be included in the audit as well.

Our annual **Spring Clean-Up** will be scheduled whenever Old Man Winter decides to leave the area. The lawns will be raked and shrubs trimmed. A survey and possible reorganization of the basement storage areas will be included, too.

The Board also plans to review the church's **snow-removal practices**, as discussed at Council. With this winter's frequent storms and icing, the walkways around the church property were often treacherous, and more outside groups are using the church. We need to supplement our usual snow-removal coverage.

Finally, the Board is pleased to welcome two **new members** this year, Walter Scott and Don Rowell.

CHRISTIAN EDUCATION COMMITTEE

The Church School children wish to thank their church family for the **Lenten Lunch Bag contributions** to benefit David's House and students in El Salvador. It means a lot to our kids to know they helping other kids!

We are also planning a **trip to the Heifer Farm in Rutland, MA,** on May 16. More information to come.

CHURCH COUNCIL

Barry Schuster reported that the church's **By-laws** have been revised to incorporate the amendments passed at the 2015 Annual Meeting. Printed copies are available from the church office for any member of the Council or congregation atlarge who would like one.

Jon Scott reported that **three new Deacons will be commissioned** in worship on April 12. He also brought forward a recommendation that Steve Teeter be approved as a new Deacon, which Council approved unanimously.

The Deacons will plan a retreat for later in the spring, though the date is not yet certain. Jon invited input from the congregation regarding anything the Diaconate might consider or do better or differently.

Reporting for **Nominating**, Amy Driscoll said that two other spots had recently been filled—Corrine Erskine will continue on Mission and Social Action, and Don Rowell will join the Board of Governors. Council unanimously approved both nominations. Also, Gordon Sargent has graciously agreed to stay on for six months as temporary chair of the Board of Governors. Council expressed its collective gratitude to Gordon.

Treasurer Nan Parsons offered her report of 2015 activity to date, which showed typical figures for this time of the year (according to former Treasurer Todd Heatherton, whom Nan thanked for being a valuable resource). Nan reported difficulty with Liberty Utilities and the need for a short-term transfer, but she expressed no other concerns.

Jon Scott added that he'd tried to research our service with Comcast to try to negotiate better rates, but Comcast will only deal with those authorized to manage accounts. In light of this difficulty, more people will be authorized.

With recent changes in both the Treasurer and Assistant Treasurer positions, Council also discussed the recording and acknowledgment of gifts to the church. Most of our contributions are collected from the offering each week and deposited by the Assistant Treasurer. However, some larger, one-time gifts (often at year's end) have gone through the Treasurer and thus haven't appeared consistently on quarterly statements, which are generated by the Assistant Treasurer. Barry Schuster suggested that those statements should bear a disclaimer regarding this issue.

Church Adminstrator Brian Clancy requested that all **church-wide correspondence** should come from the church office, in order to ensure the most current contact information for church members. It's important to maintain consistency in all church communications. Council members generally agreed with this rationale, and suggested that the congregation should be made aware of it as well.

Brian also brought forward a request from the *a cappella* group Harmony Nights, who will perform at the

church in June. The group would like to collect donations for a summer music scholarship for students, which Council approved. Brian suggested, though, that since this wasn't the first instance of **outside groups raising funds for a specific purpose**, Council should consider how such purposes should be evaluated. Members present felt that these questions should be evaluated on a case-by-case basis.

Reporting for **Stewardship**, Jon Scott distributed an update on 2015 pledge totals, which reflect positive responses from more who regularly attend worship. Jon stressed his belief, however, that some of our current mechanisms for stewarship are inadequate. He observed that our stewardship effort lacks real-time information about who is pledging and how much. He recommended that he meet with the Treasurer and Assistant Treasurer to discuss how to improve this real-time reporting. Pete Mason supported this communication, and Amy Driscoll suggested that it would be beneficial to educate the congregation and raise its collective financial awareness.

Jon also asked for Council's input on whether pledge information could or should be discussed with the pastor, since there are instances in which pledge information might affect the nature of pastoral care. Pete Mason added that members have historically had a broad variety of preferences regarding who knows how much about contributions: some have wished to deal directly with the Treasurer, others only with the Stewardship Committee, etc. Steve Silver noted that current, best-practice standards across many denominations are for the Treasurer. Stewardship Committee, and pastor to have access to the same information. Council members unanimously agreed that **an open exchange of information would be appropriate and useful**; all trust the discretion of the pastor, the Stewardship chair and other church officers in such matters.

On behalf of **Mission and Social Action,** Jon reported that early planning had begun for a return trip to San Jose Villanueva, perhaps in April 2016. The priority would be to raise significant additional funds, both for this next trip and for the replenishment of funds spent on last fall's trip. Wendell Smith is again the primary contact.

The MSA Committee also reminds everyone that leaders are still needed for **Community Dinners** in 2015; church committees in particular are encouraged to volunteer as

He is gratified by his work on ecumenical events, just as he is by his work within our congregation.

In March the Diaconate established various individual assignments for the coming year and welcomed three new members, Steve Teeter,

Susan Montmagny, and Biff Simpson. Formal commissioning will occur in worship on April 12.

In a discussion of **communion serving practices**, Barb Teeter reviewed procedures, Hilary Ryder offered to supply juice, and Deb Scott offered to continue supplying gluten-free bread.

Steve Silver reviewed a successful Fire and Ice event at Ron Bailey's house, the Ash Wednesday service hosted by FCC, and Lenten and Holy Week programming. He is also working on organizing a day trip to Boston.

On behalf of Administrator Brian Clancy, Steve also reported that Lifetouch (formerly Olin Mills) had contacted us about publishing a **new** church directory. He explained that it would be produced at no cost to the church; Lifetouch would hope to generate individual purchases of photos. Jon Scott offered to work on this project.

Each Deacon received an individual **member list,** and all were reviewed and updated as needed. It was proposed that each Deacon make an effort to contact the members on his/her list before Easter. Jon Scott suggested that Stewardship records be reviewed to ensure that no one who made a 2015 pledge would be removed from a list or designated inactive.

Susan Montmagny distributed an **Open-and-Affirming** committee survey. Deacons can anonymously complete and return them to her.

MUSIC COMMITTEE

Meeting on March 8, the Music Committee welcomed Denise Moriearty as a new member. We also reviewed the **spring concert schedule,** which is evolving. There was some concern over conflicts with other Upper Valley concerts— Classicopia's concert on May 3, for example. In that and other cases, though, we don't usually have flexibility to schedule our concerts around external events.

The committee discussed the recent purchase of the electronic version of the revised **Presbyterian Hymnal,** not as a replacement of our current pew hymnals but as a supplement for particular hymns and for its ease of reproduction. We also shared opinions about the possibility of incorporating a **sung Lord's Prayer** in worship on occasion, either by the choir or the entire congregation. All agreed that it was worth trying, as long as there was some congregational feedback. Along the same lines, committee members expressed interest in revisiting the fall 2013 survey of our music ministry.

Henry Danaher brought a request to the committee for **professional development support,** as he would like to pursue further instruction in both choral conducting and organ, probably during the summer. Committee members agreed that providing such support was entirely reasonable, and Henry will work with chair Brian Clancy to bring a proposal to Council.

MISSION AND SOCIAL ACTION COMMITTEE

At its March meeting the MSA Committee reviewed a variety of established initiatives but focused on planning a return to **San Jose Villanueva,** possibly as soon as April 2016. The first concern for such a trip would be funding, in part to continue replenishing the funds used last fall. Wendell Smith will seek a full accounting of that trip, with help from the Church Administrator, and will solicit ideas for further fundraising.

was clear to anyone paying attention. He rode into the city on a colt, not a warhorse, coming as a king in peace. He was accompanied by just a few of his disciples, which is not exactly the way to overthrow the mightiest empire on earth. And after entering the city, Mark tells us that Jesus looked around, then left. This was not exactly a forceful occupation.

We all know what came next. The trial. The cross. And, our faith tells us, the resurrection.

If Jesus came as a different kind of king, perhaps his conquest of death needs to be understood in a new way, too. The victory on the cross shouldn't be understood as the elimination of death. That remains an ineluctable, integral part of life. Instead, what God did was throw in his lot with us, so boldly, so clearly, so powerfully that we can never, ever feel that we are alone again. Even in the face of death, we are supported, succored, surrounded by the most powerful force in the universe.

On an Easter morn long ago, Jesus rose, and in doing so, lifted up all creation with him. In defeating death, Jesus affirmed life—not life to come, but life lived now. Jesus offered, as he continues to offer, life renewed, life reimagined, to you, to me, to all. Are we ready for Easter? Are we ready for new life? Maybe we are, maybe we are not. Happily, blessedly, gracefully, it matters not. God's already freely made the gift. Jesus Christ is risen today. Alleluia!
