### The Pastoral Perspective

"Nobody could have seen this coming."

That refrain has been offered by some political leaders to excuse the slow and inadequate response to the coronavirus outbreak. The truth is we could and should have seen this coming; it was never beyond the realm of possibility or imagination. Big-budget suspense movies like "Outbreak" and "Contagion" hypothesized something like this happening. Beyond the world of fantasy, we may draw on the common historical memory of the Spanish Flu, a horrible influenza that swept the world in the aftermath of the Great War. In more recent times, we were given a taste of what an outbreak might threaten with SARS, MERS, Ebola, and the H1N1 flu. And then, much more recently, there was the news of what was happening in China, then Italy, then Spain.

So, "nobody could have seen this coming" is patently not true. Many did. A more accurate statement would be "nobody wanted to see this coming." The averted eyes. The turning away from someone in need. The inconvenient truth. The thing we need, and indeed yearn for, spurned. Should we be surprised? Who among us wants to contemplate his or her own mortality? Not many of us. But what is striking is that this dynamic of denial and avoidance doesn't just feature in reactions to warnings about the coronavirus; it is a central part of the story of Jesus and Easter.

The signs were there. Scripture was fulfilled. The word was spread. Miracles or signs were performed. For those who wished to see, it was evident that Jesus, the Messiah, was coming. But so many chose not to see the import of the Christ's arrival.

As we contemplate these failures, I think it is important that we not point fingers, or question how "they" could have dropped the ball, how "they" struck out so badly. Instead, we need to wonder if we would've done any better. Perhaps we did in the current situation. But how would we have done during that first Holy Week? Where would we have been? With the crowds cheering Jesus' entry into Jerusalem? That's possible. Would we have been in the crowd calling for his death? Perhaps. Might we have stood at the foot of the cross? Not likely.

Does this mean there is no hope for us, that we are a bunch of frauds? Not in the least. Real faith requires commitment. True faith requires

### COMMITTEE NOTES

#### CHURCH COUNCIL

To open the **March teleconference** of Council the Rev. Steve Silver thanked everyone for participating in this unusual format, dictated by the COVID-19 crisis. As this situation develops quickly, he emphasized the importance of keeping in touch, maintaining connections within our congregation, and making decisions together.

John Gilliatt reports that the Board of Governors has continued to work on estimates for insulation projects at both the parsonage and the church. Parts for the second chancel railing are ready to be installed, and both railings will be painted and finished to match the existing trim. Looking ahead to a June clean-up day, the Board hopes to line the dirt cellar with plastic to prepare for insulation, and they are investigating resurfacing the front walk in concrete rather than the current asphalt. Parsonage sewer line repairs are also needed. Lastly, a subcommittee for renovating the kitchen is assessing proposals from an outside consultant.

We've had estimates for most larger projects for some time, pending a congregational decision to move forward. The Dole Trust, two thirds of which is designated for capital improvements, has substantially accrued and may be used for some of these projects.

Stewardship chair Jon Scott noted that campaign progress necessarily would be delayed by the current COVID-19 uncertainty, but he adds that frequent visitor Lola Baldwin, who has fundraising experience, would be participating. Jon also pointed out that the suspension of worship services means a decrease in our offering collections. Even if congregation members mail in contributions, we need to prepare for people giving less than they had planned. Jon will work with Steve Silver on how to communicate about this effectively. He also noted that now might be an opportunity to make resources available for estate planning.

Trustees chair Valerie Nevel reported that recent market declines had not been too damaging for the church's investments. She is scheduling total-return distributions for this month and perhaps next as well, in part to counter a delay in the annual disbursement from the Waldo Trust. Valerie has managed cash reserves to minimize the need to sell securities in this down market. Several thanked Valerie for her diligent stewardship of the church's investments.

**Treasurer** Terry Ellison noted that income and expense numbers are as expected, though he recognizes the challenge of a probable dropoff in offering collections.

Brian Clancy reported for the **Music Committee** that no viable candidates had inquired yet about the organist and choir director position, although he cautioned that it was still relatively early in the process. The position has been listed with the national AGO and various regional chapters, along with the ACDA, the employment website Indeed, and several local organizations and email listserves. Brian also confirmed that almost all events through May in the Music at the Meetinghouse series have already been canceled because of the virus crisis.

Barb Teeter, beginning her tenure as **Diaconate** chair, reported that the group was trying to acclimate its two newest members. A primary focus at this time is updating the Deacons' member contact lists, to ensure continued connections while we are unable to gather as a congregation. Steve Silver and others recognized that everyone could be helpful in reaching out.

For Mission and Social Action. Kathy Beckett confirmed that the March Community Dinner had been canceled, as we're not fully equipped to guarantee safe food preparation and distribution, even on a take-out-only basis. We can, however, continue to promote our shopping-cart beneficiaries. Kathy also reported that visits by Hearts You Hold and Epilogos would be rescheduled once we can resume worship services. She noted the intention to survey the congregation about which mission beneficiaries we should support.

#### **Committee Meetings**

In lieu of in-person meetings at church, some FCC groups will continue to meet remotely via Zoom teleconferences.

**Church Council will meet using Zoom on April 21 at 7:00.** For information about other groups' plans to meet remotely, please contact the church office.

#### COMMITTEE NOTES

Kathy repeated an MSA request to fund four additional Epilogos scholarships (two middle-school, two elementary) for the school in SIV, for a total of \$480. Council unanimously agreed this could come from Dole mission funds, along with additional support for the Open Door Ministry at this critical time for local outreach.

In his pastor's report Steve Silver recognized the challenges of the coronavirus crisis, explaining how we're adapting worship resources to be available remotely, including an online bulletin and sermon text and some livestream component. Steve thanked Susan Sorensen for her willingness to provide music as well. It's important to maintain some routines and attempt to stay

connected, and pastoral care needs have increased. While Holy Week services are unfeasible, it is hoped that we might still hold a sunrise service in Colburn Park.

Steve was happy to report that Eliot Fay had successfully passed his ecclesiastical council evaluation. Eliot's family still plans to return to NH as he prepares for ordination and a pastoral call.

Although our campaign will pause for the moment, Steve expressed gratitude for everyone's patience and community support during this challenging period. He also appreciates that our congregation is fortunate to be in a relatively secure financial position, able to help others in our community.

#### DIACONATE

In March, the Deacons discussed the lower balance of communion donations, which fund food and gas cards for FCC's Open Door Ministry. It was suggested that the congregation be reminded of the monthly communion offering and its purpose.

The Deacons have also received updated member contact lists and considered how social distancing and hygiene concerns would affect worship practices and fellowship, including communion service, passing of the peace, and coffee hour. (Although they met prior to the actual cancellation of services, these concerns will likely remain once worship resumes.) In June the

courage. And we need to rely upon God for those things to be manifest in our lives. We need the Spirit to grant us perspective, the ability to see new things, especially the Way of Jesus, which is life-giving but also demanding.

The response to statements like "nobody could have seen this coming" is not dumb assent. Nor would it be a combative riposte. Instead, I believe the answer would be another series of questions: "Why couldn't anybody see these things? How then might we see these things? What might we do differently? How can we be alert to those things we overlook?"

The wonder of Easter is that it all happened in plain sight, right there for people to see. But they had to have the faith, the courage, the commitment to look. This year, people may not feel like celebrating. They may feel resurrection has been put on hold for the duration. They would be wrong.

Easter will happen regardless of whether we gather in our church or in Colburn Park. Resurrection depends not on a calendar. Easter and the Resurrection, the promise of new life and hope revived, those things in which we believe, for which we yearn, are also attitudes. Now more than ever, the world needs us to be Resurrection people, prepared for new beginnings, for life renewed.

So be prepared. Be ready. Something big is happening and we should not be surprised, for God told us what he would do in and through Jesus. Darkness will be overcome by light. Despair will give way to hope. Death will fall before new life.

## THE LIFE OF OUR CONGREGATION

Diaconate will serve Community Dinner, with Dawn Troutman offering to take the lead and Larry Doyle providing his cooking and baking help. As we consider our community dinner service amid virus concerns, food preparation safety will be increasingly essential, including the use of gloves and hand sanitizer and the thorough washing or disposal of dishes.

As the Diaconate considered the practice of imposing ashes on Ash Wednesday, the Rev. Steve Silver explained that he has imposed ashes at FCC since arriving ten years ago, having also done so at previous churches. According to his predecessor, the Rev. Richard Slater, an ecumenical service with imposition of ashes has long been the norm at FCC. The UCC does not specify a denomination-specific ritual, but this is an ancient practice followed widely today by the full variety of Christians.

## Call for Submissions to Next Month's Grace Notes How Are You Coping with Corona?



few words or photos with the rest of the FCC community.


#### Despite our social distance, we remain a congregation. Let's see and hear what that looks like!

## **Open Position: Organist and Choir Director**

First Congregational Church of Lebanon

First Congregational Church of Lebanon, a 200-member, open and affirming congregation of the United Church of Christ (UCC), seeks a part-time organist and choir director. Our congregation is fully committed to the vital importance of music in worship, ministry, and community life, and we are generous in supporting it. Our sanctuary is among the finest musical spaces in the area, featuring excellent acoustics as well as a beautiful Steinway L piano and a two-manual Johnson pipe organ (converted in the 1950s to electropneumatic action), both of which are used in worship. The church possesses an extensive music library of both choral and keyboard repertoire. We also host an ongoing, widely appreciated concert series, offering public performances in a variety of genres.

The primary responsibilities of this position are 1) providing and accompanying all music and hymns for one worship service weekly on Sunday mornings, and 2) directing an adult choir of 8-10 singers that rehearses on Thursday nights. We expect a typical weekly commitment of 4-5 scheduled hours at the church, plus flexible, discretionary practice time; overall, the position's responsibilities would constitute 10-12 hours per week. The position also requires participation in special services for Christmas, Lent, and Holy Week.

Applicants should offer an appropriate musical background; proficiency in both organ and piano, as a solo performer and as an accompanist; experience in choral direction; and a basic familiarity with standard, traditional church repertoire. A personal faith commitment in either the UCC or another denomination is preferable, but it is not required. Salary is negotiable, commensurate with qualifications and experience; please indicate any specific compensation requirements you might have. The position also offers professional development funds, four Sundays off per year (not during Advent or Holy Week), and use of the church for concerts and recitals; no other benefits are included. Applications accepted immediately, to start as soon as possible. Please submit all applications (cover letter and résumé) and/or questions by email to the Church Administrator, at church@fccleb.org.
